WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan of Bayambang as a Legislative body of the Municipality is empowered to review ordinances authorizing annual or supplemental appropriation of barangays in the manner prescribed by laws;

WHEREAS, the Sangguniang Barangay of Tampog, Bayambang, Pangasinan submitted its Annual Budget for Calendar Year 2017, the Sangguniang Bayan, after final evaluation, finds the same in order;

NOW THEREFORE, on motion of SB Member *Amory M. Junio*, duly seconded, it was;

RESOLVED, AS IT IS HEREBY RESOLVED by the Sangguniang Bayan in session assembled, to declare operative in its entirety the Barangay Annual Budget for Calendar Year 2017 of Barangay Tampog, Bayambang, Pangasinan as of the date fixed therein for its affectivity; provided that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the Barangay Government and shall serve as basis for auditing purposes of the Commission on Audit;


