“RESOLUTION RENEWING/UPDATING THE MEMORANDUM OF AGREEMENT FOR THE INSTALLATION OF ATM BOOTH INSIDE THE MUNICIPAL HALL OF BAYAMBANG”

Sponsored by: SBM Amory M. Junio

WHEREAS, the Depositor has allowed the installation of offsite ATM booth inside the Municipal Hall compound of Bayambang which is accessible to its employees;

WHEREAS, the LAND BANK is willing to maintain offsite ATM unit, free of charge, in the space located inside Municipal Hall compound subject to terms and condition as may be mutually agreed upon;

WHEREAS, the premises shall be used exclusively by Land Bank for ATM installation and shall not be used for any other purpose without prior written consent of the Depositor;

WHEREAS, Land Bank shall shoulder the cost of renovation of the ATM premises;

WHEREAS, the Depositor shall continue to allow the electric installations required for the ATM unit and its premises;

WHEREAS, power and lighting consumption of the ATM unit, signage and premises shall be for the account of the Depositor;

WHEREAS, the Depositor shall allow Land Bank to install data leased line/communication line to be connected to ATM unit. And all charges and billings therefore shall be for the account of Land Bank;

WHEREAS, the loss or damage to the ATM unit installed in the premises shall be investigated by Land Bank in coordination with the agency/corporation's authorized official, and if such loss or damage is a result of willful or malicious acts of the employees/representatives of the agency/corporation. Land Bank together with agency/corporation shall civilly or criminally proceed against the person/s responsible;

WHEREAS, the effectivity of this agreement, Land Bank shall be entitled to maintain the ATM unit on the Depositor's premises above provided from the date of actual occupancy and for a period of Five (5) years therefrom, which period shall be automatically renewed for another Five (5) years, thereafter;

WHEREAS, in case of termination or non-renewal of the Agreement due to mutual agreement by the parties, Land Bank agrees to surrender to the Depositor the premises, in good conditions as reasonable wear and tear will permit and without delay what so ever, avoid of all articles and effects;

WHEREAS, this Agreement shall be effective upon signing by the parties hereto and shall be valid and effective, until terminated by any party upon written notice of termination sent at least Ninety (90) days prior to the intended date;

WHEREFORE, on motion of SB Member Amory M. Junio, duly seconded it was;

RESOLVED, AS IT IS HEREBY RESOLVED, to renew/update the Memorandum of Agreement for the installation of ATM Booth inside the Municipal Hall of Bayambang;
