**”RESOLUTION ADOPTING MADAC RESOLUTION NO. 01, SERIES OF 2018  
DECLARING THE MUNICIPALITY OF BAYAMBANG AS DRUG FREE MUNICIPALITY”**

*Sponsored by SBM Ma. Catalina E. De Vera and SBM Amory M. Junio*

**WHEREAS**, consistent with the priority thrust and policies of the present administration under the leadership of His Excellency President Rodrigo Roa Duterte, the Municipality of Bayambang was able to create various organization both in the municipal and barangay levels to take charge of the drug clearing operation, monitoring and recommendation;

**WHEREAS**, the MADAC and BADAC were activated, in response to the implementation of TOKHANG, a strategy to give chance to all illegal drug-affected personalities to be free from the influence of illegal drugs by submitting themselves for a reform;

**WHEREAS**, all the seventy seven (77) Barangays of the Municipality have complied with the Parameters of Drug Cleared Barangays under RA 9165 and Dangerous Drugs Board Regulation No. 2, Series of 2007 DDB Regulation No.3, Series of 2018;

**WHEREAS**, the MADAC has allocated appropriate funds for continued barangay drug clearing operations pursuant to Section 51, Article VII of RA 9165;

**WHEREAS**, the MADAC, in coordination and collaboration with the BADAC, has caused the surrender of drug personalities to the Philippine National Police with a total number of six hundred eighty two (682);

**WHEREAS**, this Municipality has created programs for anti-illegal drug campaigns, conducted advocacy and/or preventive education seminars and symposiums, as well as the establishment of a Community Based Rehabilitation Program aptly named as “MY BUKAS PA”;

**WHEREAS**, all surrendered drug personalities have undergone such programs. Although some are already neutralized thru anti-illegal drug operations initiated by the anti-illegal drug units of the PNP and PDEA;

**WHEREAS**, after assessment and evaluation on these surrendered drug personalities, they have become useful and productive members of their respective families, and most especially they already stayed away from drugs;

**WHEREAS**, diligent efforts to locate for other drug users, pushers, manufactures, marijuana cultivators, or other drug personalities, drug den, marijuana plantation, clandestine drug laboratory, and facilities related to production of illegal drugs, prove futile, hence, no more drug personality exists or remains within this municipality;

**WHEREAS**, anti-narcotics activities in consonance with DDB’s Regulations and RA 9165 will continue in the future to maintain the municipality’s drug free status;
