WHEREAS, Republic Act No. 7719, otherwise known as the “National Voluntary Blood Services Act of 1994” was passed and enacted in order to pursue the State’s goal of attaining the objectives of the national voluntary blood program of the government;

WHEREAS, Republic Act No. 7719 declares as policy of the State, to promote and encourage voluntary blood donation by the citizenry and to instill public consciousness of the principle that blood donation is a humanitarian act;

WHEREAS, Republic Act No. 7719 declares as policy of the State, to mobilize all sectors of the community to participate in mechanism for voluntary and non-profit collection of blood;

WHEREAS, cities and municipalities must be involved actively in the implementation of the provisions of Republic Act No. 7719, to encourage community participation and to proceed with vigor the ultimate attainment of the objectives envisioned under the said law;

WHEREAS, the World Health Organization thru the Department of Health mandates the blood collection of at least 1% of the total population;

WHEREAS, the safest blood comes from voluntary, non-remunerated blood donors according to the World Health Organization and DOH Administrative Order No. 2010-001;

WHEREAS, a considerable number of members of the community who require blood during their confinement at Region I Medical Center and other hospitals, have been recipients of the Medical Center’s Blood Program;

NOW, THEREFORE, on motion of **SB Member Amory M. Junio**, duly seconded, it was;

RESOLVED AS IT IS HEREBY RESOLVED, to authorize the Local Government Unit of Bayambang, First Party, represented by Dr. Cezar T. Quiambao, Municipal Mayor to enter into a Memorandum of Understanding with Region I Medical Center, Second Party, represented by Mr. Joseph Roland O. Mejia, MD, FPSMS, MBAH, MPA, DHSM, DCDM, CESE, for the mobile blood donation;

RESOLVED FINALLY, that copies of this resolution be forwarded to the Office of the Municipal Mayor, Honorable Cezar T. Quiambao, and Mr. Joseph Roland O. Mejia, M.D., FPSMS, MBAH, MPA, SHSM, DCDM, CESE for their information and appropriate action.
