No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan of Bayambang as a Legislative body of the Municipality is empowered to review ordinances authorizing annual or supplemental appropriation of barangays in the manner prescribed by laws;

**RESOLVED, AS IT IS HEREBY RESOLVED** by the Sangguniang Bayan in session assembled, to declare operative in its entirety the Barangay Annual Budget for Calendar Year 2019 of Barangay Manambong Parte, Bayambang, Pangasinan as of the date fixed therein for its affectivity; provided that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the Barangay Government and shall serve as basis for auditing purposes of the Commission on Audit;




