WHEREAS, the Sangguniang Barangay of Pangdel, Bayambang, Pangasinan submitted its Supplemental Budget for Calendar Year 2018, the Sangguniang Bayan, after final evaluation, finds the same in order;

NOW THEREFORE, in view of the foregoing, on motion of **SB Member Amory M. Junio**, duly seconded, it was;

RESOLVED, AS IT IS HEREBY RESOLVED by the Sangguniang Bayan in session assembled to declare operative the Supplemental Budget of Barangay Pangdel, provided the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the Barangay Government of Pangdel;

RESOLVED FINALLY, the copies of this Resolution to be furnished the Barangay Council of Pangdel, Bayambang, Pangasinan, for their information and guidance.


