A RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT FOR THE SUPPLY, DELIVERY OF CONSTRUCTION MATERIALS FOR MUNICIPAL HALL BUILDING REPAIR, BAYAMBANG, PANGASINAN

WHEREAS, the Bids and Awards Committee received request from the Head of the Procuring Entity through the Office of the Municipal Administrator for the Supply, Delivery of Construction Materials for Municipal Hall Building Repair.

WHEREAS, on the basis of the said request the Bids and Awards Committee caused the publication of the advertisement for the Invitation to Bid in Phil-GEPS website (<a href="https://www.philgeps.gov.ph">www.philgeps.gov.ph</a>) on February 01, 2019 – February 20, 2019 which was created on January 31, 2019 & at newspaper of local circulation continuously for seven (7) calendar days;

WHEREAS, in response to the said advertisement, one bidder expressed his interest in participating in the procurement process of the Supply, Delivery of Construction Materials for Municipal Hall Building Repair.

WHEREAS, on February 20, 2019, the Opening of Bids was conducted at the Conference Room, Municipal Building, Bayambang, Pangasinan and upon careful examination and checking of bid validity, the Bids and Awards Committee declared Georavin Construction and Supplies "COMPLYING".

WHEREAS, Georavin Construction and Supplies bid As Read was Two Million Two Hundred Sixteen Thousand Five Hundred Twenty-Five Pesos Only (PhP 2,216,525.00).

WHEREAS, after careful evaluation and post-qualification by the Technical Working Group (TWG), Georavin Construction and Supplies of Poblacion, Labrador, Pangasinan was declared "RESPONSIVE";

WHEREFORE, the BAC RESOLVE, AS IT IS HEREBY RESOLVED, to recommend the Award of the Contract for the SUPPLY, DELIVERY OF CONSTRUCTION MATERIALS FOR MUNICIPAL HALL BUILDING REPAIR in favor of GEORAVIN CONSTRUCTION AND SUPPLIES as the SINGLE CALCULATED AND RESPONSIVE BID in the amount of TWO MILLION TWO HUNDRED SIXTEEN THOUSAND FIVE HUNDRED TWENTY-FIVE PESOS (PhP 2,216,525.00) ONLY.
