**A RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT FOR THE  
PROCUREMENT OF RESCUE VEHICLES LOT-1: 29-SEATER RESCUE VEHICLE,  
BAYAMBANG, PANGASINAN**

**WHEREAS**, the Bids and Awards Committee received request from the Head of the Procuring Entity through the Office of the Municipal Administrator for the Procurement of Rescue Vehicles Lot-1: 29-Seater Rescue Vehicle.

**WHEREAS**, on the basis of the said request the Bids and Awards Committee caused the publication of the advertisement for the Invitation to Bid in Phil-GEPS website ([www.philgeps.gov.ph](http://www.philgeps.gov.ph)) on December 21, 2018 – January 15, 2019 which was created on December 19, 2018 & at newspaper of local circulation (The Pangasinan Star) on December 19, 2018 – December 25, 2018 continuously for seven (7) calendar days;

**WHEREAS**, in response to the said advertisement, one bidder expressed his interest in participating in the procurement process of the Procurement of Rescue Vehicles Lot-1: 29-Seater Rescue Vehicle.

**WHEREAS**, on January 15, 2019, the Opening of Bids was conducted at the Conference Room, Municipal Building, Bayambang, Pangasinan and upon careful examination and checking of bid validity, the Bids and Awards Committee declared Hyundai Cabanatuan City – Genesis Auto Corporation “COMPLYING”.

**WHEREAS**, Hyundai Cabanatuan City – Genesis Auto Corporation bid As Read was Three Million Two Hundred Ninety Five Thousand Pesos Only (PhP 3,295,000.00).

**WHEREAS**, after careful evaluation and post-qualification by the Technical Working Group (TWG), Hyundai Cabanatuan City – Genesis Auto Corporation of KM. 108 Maharlika Highway, Sumacab Este, Cabanatuan City, Nueva Ecija was declared “RESPONSIVE”;

**WHEREFORE**, the BAC RESOLVE, AS IT IS HEREBY RESOLVED, to recommend the Award of the Contract for the **PROCUREMENT OF RESCUE VEHICLES – LOT-1: 29-SEATER RESCUE VEHICLE** in favor of **HYUNDAI CABANATUAN CITY – GENESIS AUTO CORPORATION** as the **SINGLE CALCULATED AND RESPONSIVE BID** in the amount of **THREE MILLION TWO HUNDRED NINETY FIVE THOUSAND PESOS (PhP 3,295,000.00) ONLY**.





**NOW, THEREFORE, WE**, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:






