WHEREAS, on December 05, 2018, the Opening of Bids was conducted at the Conference Room, Municipal Building, Bayambang, Pangasinan and upon careful examination and checking of bid validity, the Bids and Awards Committee declared Impressionista Publishing "COMPLYING".


WHEREAS, Impressionista Publishing bid As Read was One Million Four Hundred Eighty Thousand Pesos Only (PhP 1,480,000.00).





To recommend for approval by the Municipal Mayor of the Municipality of Bayambang the foregoing findings.




