**A RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT FOR THE
PROCUREMENT OF RESCUE VEHICLES LOT-2: UTILITY RESCUE VEHICLE,

WHEREAS, on the basis of the said request the Bids and Awards Committee caused the publication of the advertisement for the Invitation to Bid in Phil-GEPS website (www.philgeps.gov.ph) on December 21, 2018 – January 15, 2019 which was created on December 19, 2018 & at newspaper of local circulation (The Pangasinan Star) on December 19, 2018 – December 25, 2018 continuously for seven (7) calendar days;

WHEREAS, in response to the said advertisement, one bidder expressed his interest in participating in the procurement process of the Procurement of Rescue Vehicles Lot-2: Utility Rescue Vehicle.

WHEREAS, on January 15, 2019, the Opening of Bids was conducted at the Conference Room, Municipal Building, Bayambang, Pangasinan and upon careful examination and checking of bid validity, the Bids and Awards Committee declared Machsource Corporation "COMPLYING".

WHEREAS, Machsource Corporation bid As Read was One Million Ninety Five Thousand Pesos Only (PhP 1,095,000.00).




To recommend for approval by the Municipal Mayor of the Municipality of Bayambang the foregoing findings.






