


To recommend for approval by the Municipal Mayor of the Municipality of Bayambang the foregoing findings.



WHEREAS, on December 05, 2018, the Opening of Bids was conducted at the Conference Room, Municipal Building, Bayambang, Pangasinan and upon careful examination and checking of bid validity, the Bids and Awards Committee declared Impressionista Publishing "COMPLYING".



WHEREAS, after careful evaluation and post-qualification by the Technical Working Group (TWG), Impressionista Publishing of Maharlika Road, Brgy. Abar 2nd, San Jose City, Nueva Ecija was declared "RESPONSIVE";


WHEREFORE, the BAC RESOLVE, AS IT IS HEREBY RESOLVED, to recommend the Award of the Contract for the SUPPLY DELIVERY OF SCHOOL SUPPLIES-LOT 3: SCHOOL SUPPLIES in favor of IMPRESSIONISTA PUBLISHING as the LOWEST CALCULATED AND RESPONSIVE BID in the amount of ONE MILLION NINE HUNDRED NINETY THREE THOUSAND FIVE HUNDRED TWO PESOS (PhP 1,993,502.00) ONLY.






