**A RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT FOR THE
PROCUREMENT OF ONE (1)-UNIT UTILITY RESCUE VEHICLE, BAYAMBANG,

WHEREAS, the Bids and Awards Committee received request from the Head of the Procuring Entity through the Office of the Municipal Administrator for the Procurement of One (1)-Unit Utility Rescue Vehicle.

WHEREAS, on the basis of the said request the Bids and Awards Committee caused the publication of the advertisement for the Invitation to Bid in Phil-GEPS website (www.philgeps.gov.ph) on February 01, 2019 – February 20, 2019 which was created on January 31, 2019 & at newspaper of local circulation continuously for seven (7) calendar days;

WHEREAS, in response to the said advertisement, one bidder expressed his interest in participating in the procurement process of the Procurement of One (1)-Unit Utility Rescue Vehicle.

WHEREAS, on February 20, 2019, the Opening of Bids was conducted at the Conference Room, Municipal Building, Bayambang, Pangasinan and upon careful examination and checking of bid validity, the Bids and Awards Committee declared Machsorce Corporation "COMPLYING".

WHEREAS, Machsorce Corporation bid As Read was One Million Ninety Five Thousand Pesos Only (PhP 1,095,000.00).

WHEREAS, after careful evaluation and post-qualification by the Technical Working Group (TWG), Machsorce Corporation of Rizal Avenue, San Carlos City, Pangasinan was declared "RESPONSIVE";

WHEREFORE, the BAC RESOLVE, AS IT IS HEREBY RESOLVED, to recommend the Award of the Contract for the **PROCUREMENT OF ONE (1)-UNIT UTILITY RESCUE VEHICLE** in favor of **MACHSOURCE CORPORATION** as the **SINGLE CALCULATED AND RESPONSIVE BID** in the amount of **ONE MILLION NINETY FIVE THOUSAND PESOS (PhP 1,095,000.00) ONLY**.

To recommend for approval by the Municipal Mayor of the Municipality of Bayambang the foregoing findings.




