A RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT FOR THE CONSTRUCTION OF POTABLE WATER SUPPLY (PWS) LEVEL-II FOR RHU-IV, BAYAMBANG, PANGASINAN

WHEREAS, the Bids and Awards Committee received request from the Head of the Procuring Entity through the Office of the Municipal Administrator for the Construction of Potable Water Supply (PWS) Level-II for RHU-IV.

WHEREAS, on the basis of the said request the Bids and Awards Committee caused the publication of the advertisement for the Invitation to Bid in Phil-GEPS website (www.philgeps.gov.ph) on December 21, 2018 – January 15, 2019 which was created on December 19, 2018 & at newspaper of local circulation (The Pangasinan Star) on December 19, 2018 – December 25, 2018 continuously for seven (7) calendar days;

WHEREAS, in response to the said advertisement, one bidder expressed his interest in participating in the procurement process of the Construction of Potable Water Supply (PWS) Level-II for RHU-IV.

WHEREAS, on January 15, 2019, the Opening of Bids was conducted at the Conference Room, Municipal Building, Bayambang, Pangasinan and upon careful examination and checking of bid validity, the Bids and Awards Committee declared Georavin Construction and Supplies “COMPLYING”.

WHEREAS, Georavin Construction and Supplies bid As Read was One Million Four Hundred Ninety Four Thousand Seven Hundred Seventy Five Pesos Only (PhP 1,494,775.00).

WHEREAS, after careful evaluation and post-qualification by the Technical Working Group (TWG), Georavin Construction and Supplies of Poblacion, Labrador, Pangasinan was declared “RESPONSIVE”;

WHEREFORE, the BAC RESOLVE, AS IT IS HEREBY RESOLVED, to recommend the Award of the Contract for the CONSTRUCTION OF POTABLE WATER SUPPLY (PWS) LEVEL-II FOR RHU-IV in favor of **GEORAVIN CONSTRUCTION AND SUPPLIES** as the SINGLE CALCULATED AND RESPONSIVE BID in the amount of **ONE MILLION FOUR HUNDRED NINETY FOUR THOUSAND SEVEN HUNDRED SEVENTY FIVE PESOS (PhP 1,494,775.00) ONLY**.

WHEREAS, the detailed evaluation of bids conducted on January 16, 2019 resulted in the following:






NOW, THEREFORE, WE, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


To recommend for approval by the Municipal Mayor of the Municipality of Bayambang the foregoing findings.
