**WHEREAS**, the Bids and Awards Committee received request from the Head of the Procuring Entity through the Office of the Municipal Administrator for the Provision of Office Cabinet for Annex Building.

**WHEREAS**, on the basis of the said request the Bids and Awards Committee caused the publication of the advertisement for the Invitation to Bid in Phil-GEPS website ([www.philgeps.gov.ph](http://www.philgeps.gov.ph)) on October 22, 2019 – November 11, 2019 which was created on October 21, 2019 & at newspaper of local circulation (The Pangasinan Star) on October 16, 2019 – October 22, 2019 continuously for seven (7) calendar days;

**WHEREAS**, in response to the said advertisement, three bidders expressed their interest in participating in the procurement process of the Provision of Office Cabinet for Annex Building.

**WHEREAS**, on November 11, 2019, the Opening of Bids was conducted at the Conference Room, Municipal Building, Bayambang, Pangasinan and upon careful examination and checking of bid validity, the Bids and Awards Committee declared Sofia Plus Trading "COMPLYING".

**WHEREAS**, Sofia Plus Trading bid As Read was Three Hundred Nineteen Thousand Three Hundred Forty Nine Pesos (PhP 319,349.00) Only.

**WHEREAS**, after careful evaluation and post-qualification by the Technical Working Group (TWG), Sofia Plus Trading of 092 Poblacion St., Barangay Rizal, Sta. Rosa, Nueva Ecija was declared "RESPONSIVE";


**WHEREAS**, the issuance of Notice of Award will be on January 3 for the Calendar Year 2020 where the Source of Fund for the Project will be charged;







**NOW, THEREFORE, WE**, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:




