A RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT FOR THE PURCHASE OF AUTOMATED PROCUREMENT AND MARKET COLLECTION SYSTEM, BAYAMBANG, PANGASINAN

WHEREAS, the Bids and Awards Committee received request from the Head of the Procuring Entity through the Office of the Municipal Administrator for the Purchase of Automated Procurement and Market Collection System.

WHEREAS, on the basis of the said request the Bids and Awards Committee caused the publication of the advertisement for the Invitation to Bid in Phil-GEPS website (www.philgeps.gov.ph) on October 22, 2019 – November 11, 2019 which was created on October 21, 2019 & at newspaper of local circulation (The Pangasinan Star) on October 16, 2019 – October 22, 2019 continuously for seven (7) calendar days;

WHEREAS, in response to the said advertisement, one bidder expressed his interest in participating in the procurement process of the Purchase of Automated Procurement and Market Collection System.

WHEREAS, on November 11, 2019, the Opening of Bids was conducted at the Conference Room, Municipal Building, Bayambang, Pangasinan and upon careful examination and checking of bid validity, the Bids and Awards Committee declared CLSE Software Services, Inc. "COMPLYING".

WHEREAS, CLSE Software Services, Inc. bid As Read was Nine Hundred Thousand Pesos (Php 900,000.00) Only.

WHEREAS, after careful evaluation and post-qualification by the Technical Working Group (TWG), CLSE Software Services, Inc. of Unit 805 Cityland Herrera Tower 98 V.A. Rufino Cor., Valero St. Salcedo Village, Makati City, Metro Manila was declared "RESPONSIVE";

WHEREFORE, the BAC RESOLVE, AS IT IS HEREBY RESOLVED, to recommend the Award of the Contract for the PURCHASE OF AUTOMATED PROCUREMENT AND MARKET COLLECTION SYSTEM, in favor of CLSE SOFTWARE SERVICES, INC. as the SINGLE CALCULATED AND RESPONSIVE BID in the amount of NINE HUNDRED THOUSAND PESOS (PHP 900,000.00) ONLY.




