WHEREAS, the Bids and Awards Committee received request from the Head of the Procuring Entity through the Office of the Municipal Administrator for the Construction of Potable Water Supply (PWS) Level-II for RHU-III.

WHEREAS, on the basis of the said request the Bids and Awards Committee caused the publication of the advertisement for the Invitation to Bid in Phil-GEPS website (www.philgeps.gov.ph) on December 21, 2018 – January 15, 2019 which was created on December 19, 2018 & at newspaper of local circulation (The Pangasinan Star) on December 19, 2018 – December 25, 2018 continuously for seven (7) calendar days;

WHEREAS, in response to the said advertisement, one bidder expressed his interest in participating in the procurement process of the Construction of Potable Water Supply (PWS) Level-II for RHU-III.

WHEREAS, on January 15, 2019, the Opening of Bids was conducted at the Conference Room, Municipal Building, Bayambang, Pangasinan and upon careful examination and checking of bid validity, the Bids and Awards Committee declared Georavin Construction and Supplies “COMPLYING”.




NOW, THEREFORE, WE, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:
