WHEREAS, the detailed evaluation of bids conducted on February 21, 2019 resulted in the following:





NOW, THEREFORE, WE, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


To recommend for approval by the Municipal Mayor of the Municipality of Bayambang the foregoing findings.

A RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT FOR THE SUPPLY, DELIVERY OF MATERIALS FOR LGU LANDSCAPING, BAYAMBANG, PANGASINAN

WHEREAS, the Bids and Awards Committee received request from the Head of the Procuring Entity through the Office of the Municipal Administrator for the Supply, Delivery of Materials for LGU Landscaping.

WHEREAS, on the basis of the said request the Bids and Awards Committee caused the publication of the advertisement for the Invitation to Bid in Phil-GEPS website (www.philgeps.gov.ph) on February 01, 2019 – February 20, 2019 which was created on January 31, 2019 & at newspaper of local circulation continuously for seven (7) calendar days;

WHEREAS, in response to the said advertisement, one bidder expressed his interest in participating in the procurement process of the Supply, Delivery of Materials for LGU Landscaping.

WHEREAS, on February 20, 2019, the Opening of Bids was conducted at the Conference Room, Municipal Building, Bayambang, Pangasinan and upon careful examination and checking of bid validity, the Bids and Awards Committee declared Georavin Construction and Supplies "COMPLYING".


