A RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT FOR THE SUPPLY DELIVERY OF CONSTRUCTION MATERIALS FOR SANGGUNIANG BAYAN OFFICE IMPROVEMENT, BAYAMBANG, PANGASINAN

WHEREAS, the Bids and Awards Committee received request from the Head of the Procuring Entity through the Office of the Municipal Administrator for the Supply Delivery of Construction Materials for Sangguniang Bayan Office Improvement, Bayambang, Pangasinan.

WHEREAS, on the basis of the said request the Bids and Awards Committee caused the publication of the advertisement for the Invitation to Bid in Phil-GEPS website (www.philgeps.gov.ph) on August 26, 2019 – September 16, 2019 which was created on August 23, 2019 & at newspaper of local circulation (The Pangasinan Star) continuously for seven (7) calendar days;

WHEREAS, in response to the said advertisement, one bidder expressed its interest in participating in the procurement process of the Supply Delivery of Construction Materials For Sangguniang Bayan Office Improvement, Bayambang, Pangasinan.

WHEREAS, on September 16, 2019, the Opening of Bids was conducted at the Conference Room, Municipal Building, Bayambang, Pangasinan and upon careful examination and checking of bid validity, the Bids and Awards Committee declared Welmary Construction & Supply "COMPLYING".

WHEREAS, Welmary Construction & Supply bid As Read was Four Hundred Fifty One Thousand and Six Hundred Forty Pesos (PhP 451,640.00) Only.

WHEREAS, after careful evaluation and post-qualification by the Technical Working Group (TWG), Welmary Construction & Supply of #126 Brgy. Capataan, San Carlos City, Pangasinan was declared "RESPONSIVE";


WHEREFORE, the BAC RESOLVE, AS IT IS HEREBY RESOLVED, to recommend the Award of the Contract for the CONSTRUCTION OF CORE LOCAL ACCESS ROAD, BAYAMBANG, PANGASINAN in favor of Welmary Construction & Supply as the LOWEST CALCULATED AND RESPONSIVE BID in the amount of FOUR HUNDRED FIFTY ONE THOUSAND AND SIX HUNDRED FORTY PESOS (PhP 451,640.00) ONLY.




To recommend for approval by the Municipal Mayor of the Municipality of Bayambang the foregoing findings.


