**A RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT FOR THE SUPPLY DELIVERY OF MEDICINES FOR RHU-I, BAYAMBANG, PANGASINAN**

**WHEREAS**, the Bids and Awards Committee received request from the Head of the Procuring Entity through the Office of the Municipal Administrator for the Supply Delivery of Medicines for RHU-I.

**WHEREAS**, on the basis of the said request the Bids and Awards Committee caused the publication of the advertisement for the Invitation to Bid in Phil-GEPS website ([www.philgeps.gov.ph](http://www.philgeps.gov.ph)) on December 21, 2018 – January 15, 2019 which was created on December 19, 2018 & at newspaper of local circulation (The Pangasinan Star) on December 19, 2018 – December 25, 2018 continuously for seven (7) calendar days;

**WHEREAS**, in response to the said advertisement, one bidder expressed his interest in participating in the procurement process of the Supply Delivery of Medicines for RHU-I.

**WHEREAS**, on January 15, 2019, the Opening of Bids was conducted at the Conference Room, Municipal Building, Bayambang, Pangasinan and upon careful examination and checking of bid validity, the Bids and Awards Committee declared Cedemed Pharma Distributor "COMPLYING".

**WHEREAS**, Cedemed Pharma Distributor bid As Calculated was Three Hundred Fourteen Thousand Four Hundred Forty Seven and 46/100 Pesos Only (PhP 314,447.46).

**WHEREAS**, after careful evaluation and post-qualification by the Technical Working Group (TWG), Cedemed Pharma Distributor of 221 2nd Flr. P & C Fernandez, Perez Blvd., Dagupan City was declared "RESPONSIVE";

**WHEREFORE**, the BAC RESOLVE, AS IT IS HEREBY RESOLVED, to recommend the Award of the Contract for the SUPPLY DELIVERY OF MEDICINES FOR RHU-I in favor of CEDEMED PHARMA DISTRIBUTOR as the LOWEST CALCULATED AND RESPONSIVE BID in the amount of THREE HUNDRED FOURTEEN THOUSAND FOUR HUNDRED FORTY SEVEN AND 46/100 PESOS (PhP 314,447.46) ONLY.



**NOW, THEREFORE, WE**, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:






