**A RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT FOR THE PURCHASE OF SNACKS FOR MOTHER'S CLASSES FOR 2019 – IDOL KO SI NANAY CLASSES, ETC. IN 77 BARANGAYS, BAYAMBANG, PANGASINAN**

**WHEREAS**, the Bids and Awards Committee received request from the Head of the Procuring Entity through the Office of the Municipal Administrator for the Purchase of Snacks for Mother's Classes for 2019 – Idol Ko Si Nanay Classes, etc. in 77 Barangays.

**WHEREAS**, on the basis of the said request the Bids and Awards Committee caused the publication of the advertisement for the Invitation to Bid in Phil-GEPS website ([www.philgeps.gov.ph](http://www.philgeps.gov.ph)) on November 15, 2018 – December 05, 2018 which was created on November 14, 2018 & at newspaper of local circulation (The Pangasinan Star) on November 14-20, 2018 continuously for seven (7) calendar days;

**WHEREAS**, in response to the said advertisement, two bidders expressed their interest in participating in the procurement process of the Purchase of Snacks for Mother's Classes for 2019 – Idol Ko Si Nanay Classes, etc. in 77 Barangays.

**WHEREAS**, on December 05, 2018, the Opening of Bids was conducted at the Conference Room, Municipal Building, Bayambang, Pangasinan and upon careful examination and checking of bid validity, the Bids and Awards Committee declared Mega Star Printers, Enterprises and Services "COMPLYING".

**WHEREAS**, Mega Star Printers, Enterprises and Services bid As Read was Three Hundred Eighteen Thousand Three Hundred Eighteen Pesos Only (PhP 318,318.00).

**WHEREAS**, after careful evaluation and post-qualification by the Technical Working Group (TWG), Mega Star Printers, Enterprises and Services of 964 National Highway, Anolid, Mangaldan, Pangasinan was declared "RESPONSIVE";

**WHEREFORE**, the BAC RESOLVE, AS IT IS HEREBY RESOLVED, to recommend the Award of the Contract for the **PURCHASE OF SNACKS FOR MOTHER'S CLASSES FOR 2019-IDOL KO SI NANAY CLASSES, ETC. IN 77 BARANGAYS** in favor of **MEGA STAR PRINTERS, ENTERPRISES AND SERVICES** as the **LOWEST CALCULATED AND RESPONSIVE BID** in the amount of **THREE HUNDRED EIGHTEEN THOUSAND THREE HUNDRED EIGHTEEN PESOS (PhP 318,318.00) ONLY**.






