WHEREAS, on December 05, 2018, the Opening of Bids was conducted at the Conference Room, Municipal Building, Bayambang, Pangasinan and upon careful examination and checking of bid validity, the Bids and Awards Committee declared Cedemed Pharma Distributor "COMPLYING".


WHEREAS, Cedemed Pharma Distributor bid As Read was Five Hundred Ninety Four Thousand Pesos Only (PhP 594,000.00).




NOW, THEREFORE, WE, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


To recommend for approval by the Municipal Mayor of the Municipality of Bayambang the foregoing findings.




