**WHEREAS**, under Rule XIII, Article 64 of the Implementing Rules and Regulations of the Local Government Code of 1991 and DILG Memorandum Circular No. 2019-72 dated 22 May 2019 only accredited organizations shall be qualified for representation in the local special bodies of a local government unit;

**WHEREAS**, under Section 108 of the Local Government Code of 1991, the Sangguniang Bayan is tasked to accredit non-government organizations for membership in the local special bodies, subject, however, to criteria as maybe provided for by law;

**WHEREAS**, Telbang Hillside Farmers Association, applied for accreditation and the Sangguniang Bayan, with the favorable recommendation of the Committee Rules, Laws and Ordinances, and Committee on Cooperatives and Peoples Participation, found that this non-government organization-applicant had complied with and met the necessary criteria as provided under Rule XIII, Article 64 of the implementing rules and regulations of the Local Government Code of 1991 and DILG Memorandum Circular No. 2019-72 dated 22 May 2019;

**NOW THEREFORE**, on motion of **SB Member Philip R. Dumalanta**, duly seconded, it was;

**RESOLVED AS IT IS HEREBY RESOLVED**, to accredit the Telbang Hillside Farmers Association, for the purpose of seeking representation in the local special bodies of the Municipal Government of Bayambang;

**RESOLVED FURTHER**, that copies of this resolution be forwarded to the Office of the Municipal Mayor, Honorable Cezar T. Quiambao, and Telbang Hillside Farmers Association for their information and appropriate action.
