A RESOLUTION RECOMMENDING THE HEAD OF THE PROCURING ENTITY (HoPE), MUNICIPAL MAYOR OF BAYAMBANG, BAYAMBANG, PANGASINAN TO UNDERTAKE THE ALTERNATIVE MODE OF PROCUREMENT (TWO FAILED BIDDINGS) FOR THE PURCHASE OF TWO (2) UNITS SERVICE VEHICLES.

WHEREAS, Section 53 of the IRR 9184 states that Negotiated Procurement is a method of procurement of goods, infrastructure projects and consulting services whereby the procuring entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultants in case of two failed biddings.

WHEREAS, 53.1 of the IRR 9184 **TWO FAILED BIDDINGS** states that where there has been failure of public bidding for the second time as provided in Section 35 of the Act in this IRR.

WHEREAS, 53.1.3 states that any requirements, guidelines, documents, clarifications, or other information relative to the negotiations that are communicated by the procuring entity to a supplier, contractor, or consultant shall be communicated on an equal basis to all other suppliers, contractors, consultants engaging in negotiations with the procuring entity relative to the procurement;



A RESOLUTION OF BIDS AND AWARDS COMMITTEE, BAYAMBANG, PANGASINAN, RECOMMENDING THE AWARD OF CONTRACT ON THE PURCHASE OF TWO (2) UNITS SERVICE VEHICLES AT BAYAMBANG, PANGASINAN THRU NEGOTIATED PROCUREMENT AS PROVIDED FOR IN RULE XVI OF THE R.A. 9184 AND ITS REVISED IRR.

WHEREAS, Section 53 of the IRR 9184 states that Negotiated Procurement is a method of procurement of goods, infrastructure projects and consulting services whereby the procuring entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultants in case of two failed biddings.

WHEREAS, 53.1 of the IRR 9184 **TWO FAILED BIDDINGS** states that where there has been failure of public bidding for the second time as provided in Section 35 of the Act in this IRR.

WHEREAS, 53.1.3 states that any requirements, guidelines, documents, clarifications, or other information relative to the negotiations that are communicated by the procuring entity to a supplier, contractor, or consultant shall be communicated on an equal basis to all other suppliers, contractors, consultants engaging in negotiations with the procuring entity relative to the procurement;

WHEREAS, the herein procurement chosen promotes economy and efficiency and that the most advantageous price for the government shall be obtained; and that it complies with the existing laws as per Republic Act 9184 Implementing Rules and Regulations Article XVI Alternative Methods of Procurement, Section 53.1. Two Failed Biddings;


