RESOLVED, by the Sangguniang Bayan in session assembled, to approve Barangay Resolution No. 35, Series of 2019 embodying the Annual Investment Program of Barangay Mangayao, Bayambang, Pangasinan for the Calendar Year 2020 amounting to TWO MILLION ONE HUNDRED THIRTY-ONE THOUSAND NINE HUNDRED EIGHTY-FOUR PESOS AND 51/100 ONLY (Php2,131,984.81). Provided, that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations;
