QUIAMBAO, MUNICIPAL MAYOR TO ENTER INTO AND SIGN A SUPPLEMENTAL MEMORANDUM OF AGREEMENT WITH DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT REPRESENTED BY MARCELO NICOMEDES J. CASTILLO, REGIONAL DIRECTOR, FOR THE IMPLEMENTATION OF LIVELIHOOD PROJECTS OF SUSTAINABLE LIVELIHOOD PROGRAM PARTICIPANTS IN THE MUNICIPALITY OF BAYAMBANG, PANGASINAN”

WHEREAS, the DSWD-Field Office I and the LGU Bayambang, Pangasinan as Philippine government agencies are duty-bound to render and/or delivery public goods and services to Filipino citizens for the improvement of their well-being and general welfare;

WHEREAS, the DSWD-Field Office I as the lead government agency in social protection, welfare and development, contributes to poverty alleviation and empowerment of the disadvantaged through the provision of appropriate interventions and the promotion of the rights and welfare of the disadvantaged through local and national policies, programs, projects and services implemented with and/or through local government units (LGU's), people's organizations (POs), other government organizations (GOs) and other members of civil society;

WHEREAS, the DSWD-Field Office I has continuously implemented poverty reduction programs such as the Sustainable Livelihood Program (SLP) which is mainly a community-based capacity building program that involves a two-track system in which participants are given the option to take either the (a) Micro-enterprise Development track or the (b) Employment Facilitation track after participating in social preparation and capacity-building activities to the conducted by the project development officers from different regions;

WHEREAS, the LGU Bayambang, contributes to the same advocacy through provision of Micro-enterprise Development and Employment Facilitation of Sustainable Livelihood Program (SLP) participants prioritizing the Pantawid Pamilya/Philippine Statistics Authority (PSA) poor beneficiaries;

WHEREAS, the DSWD-Field Office I and the LGU Bayambang, Pangasinan in support of their agreement on the Sustainable Livelihood Programs projects towards livelihood and food security microenterprise development models for beneficiaries of the SLP;

WHEREAS, in view thereof, there is a need to authorize Honorable Dr. Cezar T. Quiambao, to enter into and sign a Supplemental Memorandum of Agreement with Department of Social Welfare and Development represented by Marcelo Nicomedes J. Castillo, Regional Director, for the implementation of livelihood projects of sustainable livelihood program participants in the Municipality of Bayambang, Pangasinan;

RESOLVED AS IT IS HEREBY RESOLVED, to authorize the Local Government Unit of Bayambang represented by Dr. Cezar T. 
