WHEREAS, in response to the said advertisement, three bidders expressed their interest in participating in the procurement process of the **Purchase of Service Vehicle for Admin Office**.

WHEREAS, on **February 24, 2020**, the Opening of Bids was conducted at the Conference Room, Municipal Building, Bayambang, Pangasinan and upon careful examination and checking of bid validity, the Bids and Awards Committee declared **Toyota Dagupan City Incorporated** "COMPLYING".

WHEREAS, **Toyota Dagupan City Incorporated** bid As Read was **One Million Five Hundred Thousand Pesos (PhP 1,500,000.00) Only**.

WHEREAS, after careful evaluation and post-qualification by the Technical Working Group (TWG), **Toyota Dagupan City Incorporated** of Diversion Road, San Miguel, Calasiao Pangasinan was declared "RESPONSIVE";




NOW, THEREFORE, WE, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


To recommend for approval by the Municipal Mayor of the Municipality of Bayambang the foregoing findings.




