

.. Contract of Agreement ..

KNOW ALL MEN BY THESE PRESENTS:


THIS AGREEMENT made this 16th day of **February 2022** between the Local Government Unit of Bayambang, Pangasinan, Philippines (hereinafter called "The Entity") of the one part **MARC-ERNAN ENTERPRISES** of **241 Doña Mercedes Compound Nalsian, Calasiao, Pangasinan** (hereinafter called "The Contractor") of the part:


WHEREAS, the **MUNICIPALITY OF BAYAMBANG** is desirous that **MARC-ERNAN ENTERPRISES** to execute the **SUPPLY DELIVERY OF CLINICAL LABORATORY SUPPLIES & REAGENTS FOR RHU-II** (hereinafter called "The Works") and the Municipality of Bayambang has accepted the Bid for Pesos: **THREE HUNDRED FIFTY-FOUR THOUSAND NINE HUNDRED FORTY PESOS (PHP 354,940.00) ONLY** (hereinafter called "The Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to;
2. The following documents shall be attached, deemed to form, be read and construed as part of this Agreement, to wit:
 - a) General & Special Conditions of Contract;
 - b) Technical Specifications;
 - c) Invitation to Bid;
 - d) Instruction to Bidders;
 - e) Bid Data Sheet;
 - f) Bid Form, including all the documents/statements contained in the Bidder's Bidding envelopes, as annexes;
 - g) Eligibility requirements, documents and/or statements;
 - h) Notice of Award of Contract and the Bidder's conformed thereto;
 - i) Other Contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Municipality of Bayambang **MARC-ERNAN ENTERPRISES** of **241 Doña Mercedes Compound Nalsian, Calasiao, Pangasinan** hereinafter mentioned, **MARC-ERNAN ENTERPRISES**, hereby covenants with the Municipality of Bayambang, Pangasinan to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Municipality of Bayambang hereby covenants to pay **MARC-ERNAN ENTERPRISES** of **241 Doña Mercedes Compound Nalsian, Calasiao, Pangasinan** in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


