CONTRACT OF AGREEMENT

This Agreement, made this 21st day of June, 2022 between the MUNICIPAL LOCAL GOVERNMENT UNIT OF BAYAMBANG, PANGASINAN, a municipal corporation created and existing under the laws of the Republic the Philippines with office address in Roxas St., Zone II, Bayambang, Pangasinan, duly represented herein by its Local Chief Executive, DR. CEZAR T. QUIAMBAO (hereafter the "Entity")

-and-

CHRISTIAN IAN CONSTRUCTION CORPORATION, an existing and duly registered corporation under the Philippine laws, with principal office address at No. 2 Bo. Soledad, Sta. Rosa, Nueva Ecija, duly represented herein by its president, ANGELITO D. TRINIDAD (hereafter the "Contractor").

WHEREAS, the Entity is desirous that the Contractor executes the IMPROVEMENT OF SAN GABRIEL II FARM TO MARKET ROAD WITH BRIDGE-PRDP-IB-R001-PAN-006-BAY-001-2018-AF (hereafter called "the Works") and the Entity has accepted the Bid for ONE HUNDRED SEVEN MILLION NINE HUNDRED THIRTY-TWO THOUSAND NINETY-THREE PESOS AND 15/100 ONLY (PhP 107,932,093.15) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
