#### **AN ORDER IMPLEMENTING THE DIRECTIVE OF THE PRESIDENT AND THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) TO E-SABONG OPERATORS TO SHUTDOWN ALL GAMING WEBSITES AND CEASE GAMING OPERATIONS**

**WHEREAS**, Section 447 (3) and section 458 (3) (v) of Republic Act No. 7160 or the Local Government Code of 1991, provides that local government units (LGUs) shall authorize and license the establishment, operation, and maintenance of cockpits, and regulate cockfighting and commercial breeding of gamecocks provided that existing rights should not be prejudiced;

**WHEREAS**, the Philippine Amusement and Gaming Corporation (PAGCOR), by virtue of its charter, issued the Regulatory Framework for Electronic Sabong (E-Sabong), updated as of April 27, 2022. It also issued the Regulatory Framework for E-Sabong Auxiliary Operations (ESAO) which allow licensed operators to conduct auxiliary operations in areas where no cockfights are being held. And to further bolster its revenue-generating capacity, the Regulatory Framework for E-Sabong Off-Cockpit Betting Station (OCBS) was issued to strengthen the safety and reliability perception on spaces used by gaming operators;

**WHEREAS**, PAGCOR issued a Notice, dated May 04, 2022, to all licensed e-Sabong operators to shut-down all gaming websites and cease gaming operations to include all accredited auxiliary operations and Off-Cockpit Betting Station (OCBS) effective immediately;

**WHEREAS**, pursuant to the Executive Order No. 09 issued on December 28, 2022 by President Ferdinand E. Marcos Jr., directing that all E-Sabong operations, including auxiliary E-Sabong operation, shall remain suspended nationwide.

**NOW, THEREFORE I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO**, Municipal Mayor of the Municipality of Bayambang, Province of Pangasinan, by virtue of powers vested in me by law, do hereby order the continued suspension of all E-Sabong operation, including all E-Sabong Off-Cockpit Betting Stations (OCBS) in the entire municipality of Bayambang.
