#### AMENDING E.O. NO 023 SERIES OF 2018 BY REORGANIZING THE COMPOSITION OF THE BAYAMBANG MUNICIPAL COUNCIL FOR CULTURE AND THE ARTS (BMCCA)

**WHEREAS**, the Department of Interior and Local Government (DILG), in its Memorandum Circular No. 02-81, S. 2022 has directed all Local Government Unit to create the Municipal Council for Culture and the Arts (MCCA);

**WHEREAS**, the preservation and development of the indigenous, historical, cultural and artistic heritage of our Municipality would enable all Bayambanguenos would establish and enhance their collective identity and dignity as one united community;

**WHEREAS**, such preservation and enhancement of our indigenous, historical, cultural and artistic heritage would provide our people the opportunity to relate the present life condition with that of the past that would lead to a much better future;

**WHEREAS**, among others, the areas that may be preserved and developed are those involving arts, music, dance, literary pieces, drama, cinema, visual arts and historical accounts;

**NOW THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE- QUIAMBAO**, by virtue of the powers vested in me by law as Local Chief Executive of the Municipality of Bayambang, do hereby declare the following:

**Section 1. COMPOSITION.** The Municipal Council for Culture and the Arts (MCCA) with the following composition and function, to wit:

**2.2.** Establish a Secretariat under an Executive Director for the administrative and day-to-day operations of the Council;

**2.3.** Mobilize and coordinate with agencies, organizations, associations, institutions and private companies and individuals where their support and assistance in preserving and developing the indigenous historical, cultural, artistic heritage of Bayambang can be utilized;

**2.4.** Conduct several researches and, if necessary, organize fund raising activities, receive and accept donations and other conveyances including funds, materials and other services, by gratuitous tide and other appropriate initiatives in carrying out preservation and development efforts towards the eventual establishment of a Municipal Museum;

**2.5.** May delegate decision-making functions on specific cases to Executive Director and Secretariat as it sees fit. Matters for decision that are not explicitly delegated by resolution shall require Council action;

**2.6.** Update the Municipal Mayor by submitting periodic reports regarding the progress of the work of the Council; and

**2.7.** Perform other related tasks, duties and functions as may mandated by subsequent law/ordinance or upon the directive of the Municipal Mayor.

### **Section 3. Duties and Functions of the Executive Director and Secretariat.**

#### **Main functions of the Executive Director**

- Oversees the objectives of the council.
- Presides over meetings in the absence of the Chairman, Vice Chairman and upon notice by the Chairman.
- Responsible for the day-to-day operation of the organization, which includes managing council as well as developing business plans in collaboration with the council.
- Accountable to the chairman of the council and reports to the council on a regular basis.
- Perform other related tasks and functions as provided by the Chairman of the Council.

#### **Main functions of the Secretariat**

- Organizes and make all necessary arrangements/ preparations for MCCA meetings.
- Prepares minutes of meetings ang resolutions of MCCA.
- Takes custody of MCCA documents.
- Performs related task as maybe assign by the MCCA Chairman.

#### **Section 4. Definition of Terms**

**Culture-** shall refer to the whole complex of distinctive spiritual, material, intellectual and emotional features that chat characterize a society or a social group.

**Arts-** shall refer to all artistic disciplines which include but are not limited to music, dance, drama, theatre pogroms, creative writing, literature, architecture, folk arts, visual arts, and media, and the execution and exhibition of other such allied major art forms.

**Council-** shall refer to the Municipal Council for Culture and the Arts.

**Music-** shall refer to the science or art of ordering toes or sounds in succession, in combination, and in temporal relationships to produce a composition having unity and continuity.

**Dance-** shall refer to the performance art form consisting of purposefully selected sequences of human movement. This movement has aesthetic and symbolic value, and is acknowledged as dance by performers and observers within a particular culture.

**Drama-** shall refer to the specific mode of fiction represented in performance.

**Cinema-** shall refer to the art of moving images; a visual medium that tells stories and exposes reality.

**Visual Arts-** shall refer to the arts created primarily for visual perception, as drawing, graphics, painting, sculpture, and the decorative arts, and typically exists in permanent form.

**Historical-** shall refer to the belonging to or typical of the study of history.

**Cultural-** shall refer to the ideas, customs, and social behavior of a society.
