### EXECUTIVE ORDER NO. 77 Series of 2023

#### AN ORDER TRANSFERRING THE LOCAL YOUTH DEVELOPMENT OFFICE (LYDO) TO AND UNDER THE MUNICIPAL SOCIAL WELFARE DEVELOPMENT OFFICE OF THE LOCAL GOVERNMENT UNIT OF BAYAMBANG, PANGASINAN

**WHEREAS**, *Article 2, Section 13 of the 1987 Philippine Constitution* provides that "the State recognizes the vital role of the youth in nation building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being.";

**WHEREAS**, *Section 2, paragraph 2 of Republic Act No. 8044* otherwise known as the "Youth in Nation Building Act" provides that "Youth" is the critical period in a person's growth and development from the onset of adolescence towards the peak of mature, self-reliant and responsible adulthood comprising the considerable sector of the population from the age of fifteen (15) to thirty (30) years;

**WHEREAS**, with the directives of *DILG Memorandum Circular No. 2017-36* dated 24 February 2017, the Local Government Unit of Bayambang created the Local Youth Development Office (LYDO) to promote and protect the physical, moral, spiritual, intellectual, and social well-being of youth within its area of jurisdiction;

**WHEREAS**, *Section 25 of R.A. No. 10742* states that the office of the Local Youth Development Officer may be put under the Office of the Local Chief Executive, the Office of the City Planning and Development, the Office of the Social Welfare, or in any other office deemed appropriate by the Local Government Unit (LGU);

**WHEREAS**, there is a need to issue order to address additional mandates given to LGUs regarding on Person with Disability Affairs;

**WHEREAS**, *Section 16 of R.A. No. 7160* known as the Local Government Code of 1991 states that every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, in accordance with the foregoing legal bases and justification, the Office of the Mayor hereby transfers the Local Youth Development Office (LYDO) to and under the Municipal Social Welfare and Development Office for the addressing of primary concerns of persons with disabilities and the youth in the Municipality of Bayambang, Pangasinan;

**NOW THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO**, by virtue of the power and authority vested in me as Mayor of the Municipality of Bayambang, Pangasinan, do hereby order the transfer of the Local Youth Development Office (LYDO) under the Mayor's Office to the Municipal Social Welfare and Development Office of the Local Government Unit of Bayambang.

**SECTION 1. FUNCTIONS.** The Local Youth Development Office (LYDO) shall continue performing its duties and functions to serve and address the needs and concerns of persons with disabilities and the youth in the Municipality of Bayambang, Pangasinan.

**SECTION 2. SUPERVISION.** The LYDO Officer shall coordinate and be within the supervision of the Head of the Municipal Social Welfare and Development Office in performing duties and functions in their respective offices.

**SECTION 3. BUDGETARY SUPPORT AND FUNDING.** The Municipal Government shall ensure that the necessary fund from any available local revenues is allocated for the implementation of LYDO activities for the benefit of youths in the municipality.

**SECTION 4. SEPARABILITY CLAUSE.** If any of the above provision is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

**SECTION 5. REPEALING CLAUSE.** All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order are hereby repealed, amended or modified accordingly.

**SECTION 6. EFFECTIVITY CLAUSE.** This Order shall take effect immediately and will continue until amended or revoked.

This Executive Order shall take effect immediately and will continue until amended or revoked.
