AN ORDER AMENDING EXECUTIVE ORDER NO. 76 SERIES OF 2022 ENTITLED: CREATING THE MUNICIPAL CLEARING OPERATIONS MANAGEMENT COMMITTEE AND CLEARING OPERATIONS TASK FORCE AND ESTABLISHING ROAD CLEARING OPERATIONS OFFICE AND GRIEVANCE SECTION IN THE MUNICIPALITY OF BAYAMBANG, PANGASINAN

WHEREAS, the Department of the Interior and Local Government (DILG) issued DILG Memorandum Circular 2019-121 dated July 29, 2019 directing all Local Chief Executives from the provincial down to barangay level including Local Sanggunians and all other concerned to implement road clearing operations;

WHEREAS, on February 7, 2020, the DILG issued another Memorandum Circular (DILG MC 2020-27), reiterating to the LGUs to continuously implement directive to clear all roads of illegal obstructions and further enumerates of LGUs to enact policies on road clearing, conduct road inventory, cause the removal of road obstructions, prepare displacement strategies and rehabilitation efforts and establish grievance mechanism;

WHEREAS, the Local Government of Bayambang issued Executive Order No. 76 series 2022 entitled: "Creating the Municipal Clearing Operations Management Committee and Clearing Operations Task Force and Establishing Road Clearing Operations Office and Grievance Section in the Municipality of Bayambang, Pangasinan" on December 20, 2022 to address mandates given to LGUs on road clearing operations;

WHEREAS, there is a need to amend Executive Order No. 76 series 2022, to add new members to the created Municipal Clearing Operations Management Committee to replace retired employee-member and national agency personnel-member who no longer serve in the municipality;

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor of Municipality of Bayambang, Pangasinan, by the virtue of the power vested in me by the law, do hereby amend Executive Order No. 76 series 2022, as follows:

SECTION 1. REORGANIZATION OF COMPOSITION. The created Municipal Clearing Operations Management Committee in the Executive Order No. 76 series 2022 is hereby reorganized and shall be composed of the following:

SECTION 2: DUTIES AND RESPONSIBILITIES. The Committee and Task Forces shall have the same following duties and responsibilities as stated in Executive Order No. 76 series 2022:

A. MUNICIPAL CLEARING OPERATIONS MANAGEMENT COMMITTEE

1. Require the Municipal Engineering Office on regular updating of the Inventory of Road networks in the LGU;
2. Develop and implement displacement strategies and rehabilitation plan to help those affected by road clearing operations;
3. Coordinate with the Municipal Planning and Development Coordinating Office to provide base road map of the LGU to ensure effective implementation of road clearing operations;
4. Recommend to the Mayor the revocation of business permits or business establishments with illegal structures/constructions in public roads;
5. Mobilize the Municipal and Barangay Clearing Operations Task Force to implement the actual removal or demolition of illegal structures/ constructions after due process; and
6. Submit periodic reports to the mayor and other concerned agencies related road clearing reports.

B. MUNICIPAL CLEARING OPERATIONS TASK FORCE.

1. Identify illegal structures and constructions that are occupying public roads.
2. Execute actual road clearing operations and initiate road rehabilitation effort.
3. Prepare and maintain documentation of road clearing operations to be submitted to Municipal Clearing Operations Management Committee.

C. BARANGAY CLEARING OPERATIONS TASK FORCE.

1. Implement road clearing in their respective areas of responsibilities.
2. Submit to Municipal Clearing Operations Management Committee their respective monthly accomplishment reports and other periodic reports as required by other agencies.

SECTION 3. ESTABLISHMENT OF ROAD CLEARING OPERATIONS OFFICE AND GRIEVANCE SECTION. The Municipal Engineering Office is hereby established as the Road Clearing Operations Office including the Grievance Section of the Municipal Committee. Municipal Engineer shall assign one of his staff who will from time to time receive all comments, queries and complaints from those affected by road clearing operations and who shall submit the same to the Committee Chairman.

SECTION 4. SANCTIONS. Persons violating the DILG Memoranda Circulars shall be meted with the following sanctions:

1. Business Permits of business entities/establishments committing violations related to this executive order will be revoked/cancelled subject to due process.
2. Municipal and Barangay officials and employees who committed violations relative to this executive order or have participated in the commission of such violations shall be administratively liable.

SECTION 5. UTILIZATION OF DESIGNATED MUNICIPAL HOTLINE.

The Local Government Unit of Bayambang designates #4357 as the Municipal Hotline for citizen's complaints which can be used if there are any complaints regarding the road clearing operations.

SECTION 6. SEPARABILITY CLAUSE. If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 7. REPEALING CLAUSE. All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

SECTION 8. EFFECTIVITY CLAUSE. This executive order shall take effect immediately and will continue until amended or revoked.

Let copies of this Order be furnished to Offices and Departments concerned, the MLGOO and all Barangays for their information and guidance.
