**DESIGNATION OF MR. JOSEPH ANTHONY S. QUINTO AS OFFICER-IN-CHARGE OF THE SPECIAL ECONOMIC ENTERPRISE (OIC-SEE)**

**WHEREAS**, Section 5, Article X of the 1987 Constitution States that, "Each local government unit shall have the power to create its own sources of revenues xxxx"

**WHEREAS**, Section 18 of the Local Government Code of 1991, states that "Local Government Units shall have the power and authority to establish an organization that shall be responsible for the efficient and effective implementation of their development plans, programs, objectives and priorities; to create their own sources of revenues xxxx; to acquire, develop, lease, encumber, alienate or otherwise dispose of real or personal property held by them in their proprietary capacity and to apply their resources and assets for productive, development or welfare purposes, in the exercise or furtherance of their governmental or propriety powers and functions xxxx"

**WHEREAS**, there is a need to establish a business-like approach to local enterprise management especially of the office of the Special Economic Enterprise;

**WHEREAS**, there is a need to designate an officer in charge of the Special Economic Enterprise and to specify the duties and functions of the said office;

**NOW THEREFORE, I, CEZAR T. QUIAMBAO**, by virtue of the powers vested in me by law as the Local Chief Executive, do hereby designate **MR. JOSEPH ANTHONY S. QUINTO, MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES OFFICER (MENRO)** as the concurrent **OFFICER-IN-CHARGE** of the **SPECIAL ECONOMIC ENTERPRISE**.

**SECTION 1. DESIGNATION. MR. JOSEPH ANTHONY S. QUINTO, MENRO**, is hereby designated as **the OFFICER-IN-CHARGE** of the **SPECIAL ECONOMIC ENTERPRISE**, in a Concurrent Capacity,

**SECTION 2. DUTIES AND FUNCTIONS.** In addition to his duties and responsibilities **MR. QUINTO** is hereby given the following duties, functions and responsibilities:

- a. To be in-charge of the supervision of the aggregate operations of the Local Economic Enterprises;
- b. Aside from the existing local economic enterprises, which are the public market and slaughterhouse, to look for more diversified sources of local revenue such as but not limited to the following:

*"Baley ko, Pawiben ko, Aroen ko, tan Tubungan ko"*

- c. Plan and study for the formulation of a clear policy framework for the creation and continues operation of L.E.E.s for recommendation to the Municipal Mayor and the Sangguniang Bayan;
- d. Oversee the conduct of feasibility studies, not only just to comply with bank requirements for loan purposes, but to create a self-sustaining and revenue generating local economic enterprise;
- e. Based on the feasibility studies, formulate solicited proposals for the implementation of the Local Economic Enterprise Project;
- f. Formulate plans and strategies for marketing, promoting and packaging the Local Economic Enterprise to be taken seriously by inventors;
- g. To formulate terms and conditions to entice investors but still advantageous to the Municipal government.

**SECTION 3. RENUMERATION.** This designation does not entail additional remuneration.

**SECTION 4. EFFECTIVITY.** This Executive Order shall take effect immediately and shall remain in effect unless sooner revoked or amended.

Let copies of this Order be furnished to all Departments and all government agencies concerned for their information and guidance.
