### EXECUTIVE ORDER NO. 85 *series of 2023*

#### AN ORDER RECOMPOSING THE SOCIAL PROTECTION TEAM OF THE MUNICIPALITY OF BAYAMBANG, PANGASINAN

**WHEREAS**, Social Protection as defined in NEDA-Social Development Committee (SDC) through Resolution No. 1 series of 2017, constitute policies and programs that seek to reduce poverty and vulnerability to risks and enhance the social status and rights of the marginalized by promoting and protecting livelihood and employment, protecting against hazards and sudden loss of income, and improving people's capacity to manage risks;

**WHEREAS**, a Sub-Committee on Social Protection (SCSP) under the SDC NEDA-Social Development Committee (SDC) was created through Resolution No. 02 series of 2009 to lead in the formulation and operationalization of medium-term social protection plan and other social protection policies and strategies that paved the way for the development of Social Protection Operational Framework and Strategy;

**WHEREAS**, Joint Memorandum Circular No. 01 dated January 23, 2015, of the Department of Social Welfare and Development (DSWD) and the Department of Interior and Local Government enjoins all provinces, cities, and municipalities to use the Social Protection (SP) handbook for local planning, budgeting, implementing, monitoring and evaluating Social Protection Programs;

**WHEREAS**, Republic Act No. 8425 otherwise known as Social Reform and Poverty Alleviation Act provides that the State shall adapt an area-based, sectoral and focused intervention to poverty alleviation wherein every poor Filipino family shall be empowered to meet its minimum basic needs of health, food and nutrition, water and environmental sanitation, income security, shelter and decent housing, peace and order, education and functional literacy, participation in governance, and family care and psycho-social integrity;

**WHEREAS**, the Local Government Unit of Bayambang created the Social Protection Team through Executive Order No. 67 series 2020 in support to the programs and projects of the national government in alleviating the lives of the poor and providing them necessary means of livelihood, source of income and by ensuring better quality of life;

**WHEREAS**, there is a need to recompose the Social Protection Team of the municipality in order to strengthen performance of duties and functions to ensure that social protection programs and plans in alleviating the lives of the poor Bayambanguenos are attained;

**SECTION 2. DUTIES AND FUNCTIONS.** The Social Protection Team of the municipality shall have the following duties and functions:

1. Convene all the members of the expanded Municipality Development Council (MDC) for Social Protection Risk, Vulnerability and Adaption Assessment (SPRVAA);
2. Provide implementation support to the utilization of the Social Protection Handbook including the use of Social Protection Vulnerability and Adaptation Manual (SP-VAM) for planning, implementing, monitoring and evaluating social protection programs;
3. Assist in the assessment of the risks and vulnerabilities of the locality and with the Barangay Local Government Unit (BLGU) in the performance of related programs and activities relative to the Social Protection;
4. Lead in the planning of municipal and barangay workshop for the formulation of the local Social Protection Programs on risks and vulnerabilities of the identified areas of the locality;
5. Facilitate in the conduct of the community information and education drive on the utilization of the SP Handbook;
6. Consolidate the Social Protection assessment and plans;
7. Formulate social protection program, strategies and initiatives that would reduce people's vulnerabilities and be lifted out of poverty; and
8. To do other related tasks assigned relative to Social Protection.

**SECTION 3. SEPERABILITY CLAUSE.** If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

**SECTION 4. REPEALING CLAUSE.** All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

**SECTION 5. EFFECTIVITY CLAUSE.** This Executive Order shall take effect immediately and will continue until amended or revoked.

Let copies of this Order be furnished to concerned departments, offices and barangays for their information and guidance.
