AUTHORIZING THE TRANSFER OF APPROPRIATION UNDER THE OFFICE OF THE ECOLOGICAL SOLID WASTE MANAGEMENT

WHEREAS, the amount left under account **OFFICE OF THE ECOLOGICAL SOLID WASTE MANAGEMENT-OTHER SUPPLIES AND MATERIALS** is not sufficient to meet the obligations under the said account;
