EXECUTIVE ORDER NO. 41

Series of 2024

ASSIGNING ESWMO AS THE REPOSITORY OF CONFISCATED PRODUCTS AND MATERIALS DURING ROAD CLEARING OPERATIONS IN LGU BAYAMBANG, PANGASINAN

WHEREAS, Municipal Ordinance No. 04 Series of 2021 [Section 7 (c)]empowers the Local Government Unit of Bayambang, Pangasinan to remove items, goods, and structures of good condition found on or along the national, provincial, municipal, and barangay roads and bridges during road clearing operations;

WHEREAS, it is necessary to establish a designated repository for all confiscated items to ensure proper custody and disposition;

WHEREAS, the Environmental and Solid Waste Management Office (ESWMO) of LGU Bayambang has the capacity to handle confiscated products and materials;

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby order the following:

Section 1: Designation of ESWMO as the Repository

1.1 The ESWMO of LGU Bayambang, located at the ESWMO Compound in Telbang Bayambang, Pangasinan, is hereby designated as the repository of all confiscated products and materials during road clearing operations.

1.2 The ESWMO shall be responsible for the safekeeping, inventory, and proper management of all confiscated items.

Section 2: Handling of Confiscated Items

2.1 All confiscated items shall be promptly transported to the ESWMO Compound for temporary custody and proper disposition.

2.2 The ESWMO shall ensure the documentation and recording of all confiscated items, including relevant details such as date, time, location, and description.

2.3 For disposable or perishable goods found on or along the roads and bridges, the ESWMO shall treat them as common or ordinary garbage and dispose of them accordingly, in accordance with proper waste management protocols. However, food commodities may

be given to the Provincial Jail as additional food for Persons Deprived of Liberties (PDLs), as allowed by Municipal Ordinance No. 04 Series of 2021.

Section 3: Release of Confiscated Items

3.1 Confiscated items can only be released upon payment of fines to the Treasury Department of LGU Bayambang, as stipulated in the applicable ordinances and regulations.

3.2 The ESWMO shall facilitate the release of confiscated items upon presentation of proof of payment to the Treasury Department and completion of any necessary documentation.

Section 4: Effective Date and Implementation

4.1 This Executive Order shall take effect immediately upon issuance.

4.2 The ESWMO shall coordinate with the concerned authorities involved in road clearing operations to ensure the proper implementation of this Executive Order.

4.3 All barangays, departments, and offices of LGU Bayambang shall be notified of this Executive Order and shall provide the necessary support and cooperation in its implementation.

Section 5: Repealing Clause

5.1 Any previous orders or provisions that are inconsistent with this Executive Order are hereby repealed or modified accordingly.
