AN ORDER RECONSTITUTING/ REORGANIZING DESIGNATED SAFETY OFFICERS AND PERSONNEL-IN-CHARGE IN EVERY DEPARTMENTS/OFFICES FOR THE MONITORING AND MAINTENANCE OF HEALTH AND SAFETY CONDITIONS IN THE WORKPLACE OF LGU-BAYAMBANG, PANGASINAN

WHEREAS, under Section 3, Article XIII of the 1987 Philippine Constitution, Occupational Health, and Safety is a right, hence, it is important that the Local Government of Bayambang endeavor for better working conditions for its employees. Evidenced-based studies revealed that a holistic approach, combining occupational health and safety with disease prevention, and tackling the social determination of health within the local government system framework to have a more responsive and concerted action for protecting and promoting the health of workers;

WHEREAS, the health and safety of workers in the Philippines are protected by Republic Act No. 11058 or an "An Act Strengthening Compliance with Occupational Safety and Health (OSH) Standards and providing penalties thereof";

WHEREAS, in compliance with the JOINT MEMORANDUM CIRCULAR NO. 01, Series of 2020 of Civil Service Commission (**CSC**), Department of Health (**DOH**), and Department of Labor and Employment (**DOLE**), enjoining all government agencies to comply with the Guidelines on Occupational Safety and Health Standards to ensure protection of all its workers, including Job Orders and institutional contractors, from dangers of injury, sickness and death in the workplace to ensure preservation of human lives and resources and prevent loss/damage of properties;

WHEREAS, to fully operationalize this program, there is need to reorganize/reconstitute the Designated Safety Officers and Personnel-In-Charge in Every Departments/Offices For the Monitoring and Maintenance of Health and Safety Conditions in the Workplace of LGU-Bayambang, Pangasinan created under Executive Order No. 86 series 2022 on April 03, 2023;

NOW THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor of Municipality of Bayambang, Pangasinan, by virtue of powers vested in me by law, do hereby **ORDER TO RECONSTITUTE/REORGANIZE THE DESIGNATED SAFETY OFFICERS AND PERSONNEL-IN-CHARGE IN EVERY DEPARTMENTS/OFFICES FOR THE MONITORING AND**
